Councilman Walter Stewart thanked everyone for coming to the meeting. He stated there are still many people that are not taking the COVID situation seriously. There are almost 300 million people in this country and only 53 million have been vaccinated. He reported there are over 40 million people that have COVID and 15,000 people a day are dying so this is serious. People are not wearing masks and it is better to be safe than to be sorry. He stated they need to be safe and protect each other.

Councilwoman Dorise Hagwood wished everyone a good evening and thanked attendees for coming out.
